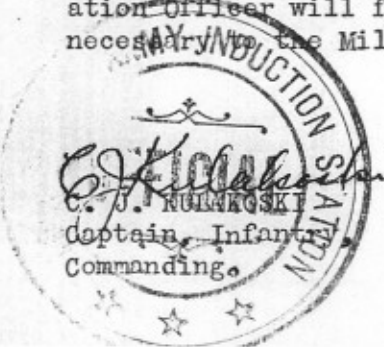

The Transportation Officer will furnish the necessary transportation. The travel directed is necessary to the Military Service and is chargeable to FD 34 P 434-02 A 0485-23.
